Consolidated Refrigerant Reclaim provides reclamation services exclusively to the Rapid Recovery franchise network. Consolidated transports, collects, consolidates and disposes of all types of refrigerants. Consolidated reclaims R-22 which is packaged in 30 lb. disposable cylinders for resale. This R-22 is then sold only in truckload quantities (1000 cans – 25 skids). Other refrigerants may be made available as reclaimed finished goods in various quantities and packaging.

Our refrigerants are sold to qualified resellers and/or reclaimers through an email bidding process using the following procedure:

- Periodically, all qualified buyers are notified via email of available product for bid. Bid deadlines are indicated in each offer. Late bids are generally not accepted.
- The bid winner will be notified and must respond according to the current terms and conditions. Bidders within 5% of the awarded bid will be informed of the sale price.
- All sales are FOB our dock. All freight must be arranged and paid for by buyer. The Bill Of Lading is to be provided by buyer. Reloading costs for overweight trucks is the responsibility of buyer.
- Buyers must provide a signed purchase order showing the correct terms and bid price prior to pickup. All purchased product must be picked up from our dock within 5 working days of bid award. Failure to comply will result in the sale being awarded to the next highest bidder.

Payment terms are NET 15 from ship date. This is NOT "pay when paid", buyers must be able to carry their own terms. FAILURE TO MEET PAYMENT TERMS EXPLICITLY WILL DISQUALIFY BUYER FROM FUTURE BID OPPORTUNITIES.

Quality disputes which cannot be resolved will result in the return of all products to Consolidated for credit of original cost. Consolidated will arrange the freight for returns and pay the cost. After receipt of returned product, Consolidated will make a determination of the validity of the claim and, based on the results, may offer restitution for initial freight costs.

Consolidated reserves the right to qualify or disqualify buyers at its sole discretion at any time.
